SUBJECT: WASC/CDE Focus on Learning Training, Part Two of a Three Part Series

The Accrediting Commission will be providing training jointly with the California Department of Education for principals, self-study coordinators and other self-study leaders. The topics to be covered in part two include:

- the gathering and analyzing of data about students and student achievement
- the assessment of the entire school program and its impact on student learning in relation to expected schoolwide learning results, academic standards, and WASC/CDE criteria
- the integration and refinement of the school's current single plan for student achievement based on the self-study findings

Part three of this series will be a one day follow-up that will be conducted in the Fall of 2010.

As emphasized at Part I training in November, please plan to share the following **drafts** at the upcoming March training:

- (1) updated student/community profile
- (2) identified critical academic needs
- (3) expected schoolwide learning results (schoolwide learner outcomes), especially those related to the identified critical academic needs
- (4) a progress report
- (5) the school's organization structure for the self-study process
